<u>Location:</u>	Model Yacht Pond, Mission Bay Park, San Diego. From I-5 exit to Sea World Drive, exit right to Ingraham Blvd, cross over one bridge, take left at light, take next left, take next right – you are at The Pond. By the way, it is a "wet pond", has a sandy beach, there is no dock, bring knee boots, wading shoes, or bare feet OK.						
Time:	Skippers' Meeting at 9:45 am or as soon the Event's Measurement procedures is done, first race 10 minutes after the warning signal each day.						
Rules:	Races are governed by the current International Sailing Federation (ISAF), 2009 – 2012, Racing Rules of Sailing as modified by Appendix E, the prescriptions of U.S. Sailing when they apply, the rules of the class entered and the San Diego Argonauts Sailing Instructions as amended. You must be a member of the American Model Yachting Association (AMYA) or an international sailing organization recognized by AMYA.						
Transmitters:	Shall comply with FCC Regulations. 2.4 GHZ transmitters are recommended, longer antennas MUST have eye protection. For lower crystal controlled transmitters please bring multiple crystals. Frequency conflicts cannot be accommodated
