**Deception Pass State Park, Whidbey Island WA, West Cranberry Lake.**

**Eligibility** Anyone with a Soling or IOM that wants to have a fun weekend in Anacortes/Oak Harbor and support Washington State Parks Centennial. Entrants must possess a Discover pass, one per car to enter the park and have paid the \$25 entrance fee per boat per regatta. AMYA membership is encouraged and all proceeds will be donated to The Deception Pass State Park Foundation whose mission is to preserve this park. No provision is made to measure boats at this event but all boats will be weighed in.

Non competitors may wish to sample other centennial events taking place in the park, and note that the Anacortes Arts and Crafts Fair is the same weekend.

**CONDUCT:** Competitors in the sport of sailing are governed by a body of rules that they are expected to follow and enforce. A fundamental principle of sportsmanship is that when competitors break a rule they will promptly take a penalty, which may be to retire. Poor competitor behavior can reflect negatively on the sport, and will not be tolerated. By entering this event, it is deemed that you accept these conditions.
