## Notice of Race

### Event

Deception Pass Model Yacht Club invites International One Metre sailors to participate in the annual DPMYC Bowman Bay Benefit (Deception Pass Park Foundation) Regatta.

### When

August 9<sup>th</sup> and 10<sup>th</sup> 2014 – Two days of fleet racing.

August 8<sup>th</sup> - Practice and early weigh in, from 10.00 am (optional).

August 9<sup>th</sup>, weigh in at 9.00 am.

August 9<sup>th</sup> and 10<sup>th</sup> Skippers meetings 9.30 am, with racing commencing at 10.00 am. No race will start after 4.00 pm, both days.

### Where

Deception Pass State Park, at the pier at Bowman Bay, dry launch in salt water. A Discover Pass or park entry fee is required to access any of the park facilities. Maps and camping reservations at [www.parks.wa.gov](http://www.parks.wa.gov).

Lunch will be provided for both days. Early weigh in and course familiarization and practice is encouraged on Friday August 8<sup>th</sup>. All skippers and helpers are invited to an after race buffet at the Lee's home on August 9th at 6.00pm.

### Eligibility

Sailors with a certificated IOM that wish to have a fun weekend in an outstanding park that have paid the \$75.00 entry are eligible to compete. Current AMYA membership or equivalent is required. Yachts must comply with the ISAF-RSD, International One Metre Class Rules and have an IOM measurement certificate with sails that have been measured and marked by the measurer. No provision is made to measure boats at this event but all boats will be weighed in – fully rigged, with battery, fin, bulb and rudder attached.
