

Notice of Race

International One Meter European Championship 2014

September 27th – October 3rd 2014

Organizing Authority

The International One Meter European Championship 2014 is organized by the Vela Club Campione del Garda in association with Gruppo Radiovelisti Idro , the IOM NCA for Italy, as approved by the International One Metre Class Association and under the overall authority of ISAF, IRSA and IYA.

1. Venue

The International One Meter Class European Championship 2014 will be held at Campione del Garda (Brescia) Italy.

2. Rules

2.1 The event will be governed by the rules as defined by The Racing Rules of Sailing as changed by appendix E.

2.2 Including the following documents-

- The IOMICA Class Championship Rules 2013,
- The International One Metre Class Rules,
- the IRSA Championship Regulations (http://www.radiosailing.org/document-files/racing/IRSA_Championship_Regulations_2013-01-01.pdf)

- Radio Sailing Addendum Q (Umpiring).

2.3 No national prescriptions will apply.

3. Eligibility

76 competitors will be accepted as per the class Championship Rules para.8.

The competition is open to International One Metre class boats selected by an IOM National Class Association in good standing with IOMICA and IRSA. The ISAF Regulations regarding eligibility apply with the additional requirements of the IOMICA Class Championship Regulations.

4. Registration

4.1 A valid IOM Class Certificate for each boat must be submitted on or before 27th June, 2014. An e-mail copy is acceptable; however the original must be made available at registration. Boats together with their measurement certificates shall be presented for registration and equipment inspection on 27-28th September 2014. The Race Committee may extend the time for registration and inspection if there is a valid reason to do so. No boat shall be eligible to race until it has been registered and has passed equipment inspection.

4.2 Eligible boat may enter by completing the entry form on this web site and sending it with the required fee.

7. The Sailing Instructions shall prevail in case of conflict with this Notice of Race, except where Rule 63.7 applies.

8. Umpires

8.1. ISAF International Umpires or International Judges or NU shall be appointed as umpires. National Judges and National Umpires may be appointed to assist.

8.2. Competitors will be required to undertake Observer duties.

8.3. An International Jury conforming to RRS Appendix N shall be appointed. appointed and the right of appeal is denied under RRS 70.5.

Furthermore, the right to reopen is denied to the extent that a boat's transfer to subsequent heats is affected.

9. Scoring and Racing System

9.1 The Championship will be raced and scored under the Heat Management System(HMS).

Entries shall be limited to 76 boats.

9.2 A minimum of five completed races shall constitute the championship.

10. Liability

10.1 All those entering or taking part in this Championship do so at their own risk and responsibility.

ISAF,IRSA, the International One Meter International Class Association, the Vela Club Campione del Garda, Gruppo Radiovelisti Idro, Modelvela Italia (IOM NCA) and any other parties involved in the organization of this event disclaim any and every responsibility whatsoever for loss, damage, injury or inconvenience that might occur to persons and goods, both on the water and ashore as a consequence of entering or participating in the Championship covered by this Notice of Race.

10.2 At all times the responsibility for the safety of their boat and themselves including the decision to participate or continue shall rest with the competitor. By entering the event it is deemed that you accept these conditions. Competitors are advised to ensure that they have adequate personal insurance that provides cover for public liability and their possible injury in Italy.
