**RULES:** The regatta will be governed by The **Racing Rules of Sailing for 2013-2016 (RRS)** as changed by RRS Appendix E, this Notice of Race (NoR), the Sailing Instructions (SI), and The Equipment Rules of Sailing. *The Sailing instructions shall prevail in case of conflict with this Notice of Race.*

**ELIGIBILITY:** The Competition is open to all DragonFlite 95 Restricted Class class boats that comply with the most current Restricted Class Rules listed at

**REGISTRATION and EVENT MEASUREMENT:** Boats shall be presented for registration between 10:00 and 12:30, Oct 28, 2016, at the sailing site for event measurement. However, the race committee may extend the time for registration and event measurement if there is a valid reason to do so. **No boat shall be eligible for racing until it has been registered and inspected for the event.**

**SCORING and RACING SYSTEM:** Scoring will be carried out in accordance with HMS 2015 as modified by the Sailing Instructions.

**2016 DF95 USA NCR**

**PRE-REGISTRATION and FEES:** Online registration will start 7/10/2016 We will have an entry list, updated online at <http://df95usancr.blogspot.com/> Early entry will help to assure no Radio Channel conflict early on. This really helps speeds things up on race days and allows us to have adequate amount of food and drinks.

Entry fee is \$65.00 per boat and includes coffee, donuts, and beverages. The fee will cover catered lunch on Saturday and Sunday **Fees are payable online prior to Oct 1, 2016 and *no refunds will be given after that date.***

**FREQUENCIES:** Permitted frequency bands are FCC-approved surface bands. Transmitters on 75 MHz must be narrow band certified. Radio frequencies will be allocated on a "first come first served" basis. NO CONFLICTS will be allowed. Each competitor is required to have a minimum of three (3) additional frequencies available. **2.4 Ghz radios are permitted and are exempt from rule E1.5 in the RRS.**

**FOOD SERVICE:** Lunch will be catered on Saturday & Sunday, Snacks and drinks will be provided throughout the event. Lunch Breaks will be determined by the race staff on site and shall be administered as needed by the PRO.

**AWARDS:** Prizes will be awarded to the first 5 positions in the final results

**LIABILITY:** All those entering or taking part in this regatta do so at their own risk and responsibility. Trinity River Yacht Club, Bass Pro Shops and or any other parties involved in the organization of this event disclaim any and all responsibility whatsoever for loss, damage, injury or inconvenience that might occur to persons and goods, both ashore and on the water as a consequence of entering or participating in the event covered by this Notice of Race. At all times the responsibility for the safety of their boat and themselves including the decision to participate or continue shall rest with the competitors. By entering this event, it is deemed that you accept these conditions. Competitors and participants are advised to ensure that they have adequate insurance that provides coverage for public liability and their possible injury in the Country and County of this event.

**ENTRY DEADLINE:** Entries must be made online no later than Oct 15, 2016. Late entries may be accepted on site on Oct 28, 2016; however, these entries will not be eligible for any apparel, or custom giveaways, *Late entries will be allowed only at the discretion of the Regatta Chairman.* No refunds after October 1, 2016
