RULES: The regatta will be governed by The Racing Rules of Sailing for 2017-2020 (RRS) as changed by RRS Appendix E, this Notice of Race NoR, the sailing instructions (SI), and the Equipment Rules of Sailing. The Sailing Instructions shall prevail in case of conflict with this NoR.

ELIGIBILITY: The competition is open to all DragonFlite 95 Restricted Class Boats that comply with the most current Restricted Class Rules listed at https://dfracing.world/df95-rules/. All entrants must be current AMYA member or their national authority.

REGISTRATION AND EVENT INSPECTION: Boats shall be presented for registration between 08:00 and 10:00 October 24, 2019 at the sailing site for event inspection. However, the race committeeman extend the time for registration and event inspections if there is a valid reason to do so. NO BOAT SHALL BE ELIGIBLE FOR RACING UNTIL IT HAS BEEN REGISTERED AND INSPECTED FOR THE EVENT.

RULES

1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS), Appendix E for RC Sailing, the prescriptions of US Sailing, the Class DR-95 Class and these Sailing Instructions. Rules of

- 1.2 Changes to the Racing Rules or Class Rules are noted in the specific instructions where they apply.
- 2. NOTICES TO COMPETITORS: Notices to competitors will be posted on the Official Notice Board located at the scorekeeping admin table at the pond at James County Park during the regatta.
- CHANGES TO THE SAILING INSTRUCTIONS: Any change to the sailing instructions will be posted before 9AM, on the day before it will take effect. OR Verbal changes to these instructions may be made at any time. All competitors will be notified of changes by the PRO.

4. SCHEDULE OF RACES

4.1 Dates of racing: Friday 10/25 0830-1200 noon Check-in, Inspections/Lunch 1300-1700, Seed Races

- 4.3 The scheduled time of the Warning signal for the first (Heat or Races) each day is 0900.
- 4.4 When there has been a postponement lasting over 3 minutes, the warning signal for the first race following the postponement and each succeeding race will be made as soon as practical, at the PRO's discretion. An audible signal will be sounded at least one (1) minute before the Warning Signal for the first race following the postponement.

5. RACING FORMAT

- 5.1 The racing format will be HMS
- 5.2 See details at link noted http://mya-uk/knowledge_base/hms-and-scoring
- 5.3 Please take your boat out of the water as soon as possible after finishing while avoiding crossing or being on the active regatta course.
- 6. THE COURSE BOARD: Course board, if used is to be located as required by Rule Append E
- 7. THE START

- 7.1 The AMYA two minute starting sequence will be used. The Warning signal is defined as when the auditory two (2) minute countdown sequence begins, (the skipper will hear "two minutes till mark"); the Preparatory signal is defined as when the countdown reaches one (1) minute before the start signal (the skipper will hear "one minute till mark"). This complies with E3.4.
- 7.2 Boats whose Warning Signal has not sounded shall stay clear of the starting area.
- 7.3 OCS (on course side) If any part of a boat's hull or equipment is on the course side of the starting line after the start signal, the line judge or PRO will attempt to hail that boat. Failure of the line judge to make a hail or a skipper to hear such a hail will NOT be grounds for PROTEST, or request for a redress hearing. This changes

Rule 62.1(a).

8. HOLDS

- 8.1 Holds will be announced periodically by the PRO at their discretion, for restroom and other breaks such as changes in weather conditions, non-stop racing for a skipper because of relegation or promotion for a battery or rig change, and for scheduled lunch breaks.
- 8.2 Each competitor may request one 5 minute hold per day to address a mechanical failure.

9. TIME LIMITS

- 9.1 If no boat has passed Mark 1, within 10 minutes of the start, the race will be abandoned.
 - 9.2 If no boat has finished within 20 minutes of the start, the race will be abandoned.
 - 9.3 Boats failing to finish within 5 minutes after the first boat finishes, will be scored DNF.

 This changes Rules 35 & A4.
 - 9.4 The PRO's watch is official for purposes of signals and time limits.
- 10. THE FINISH: THE FINISHING LINE WILL BE BETWEEN THE FINISHING MARKS

11. PENALTY SYSTEM

- 11.1 A boat touching a mark defined by Rule 31.1 shall take penalty turn as required by Rule 31.2.
- 11.2 A boat breaking a Rule in RRS Part 2, shall take a one-turn (360) alternate penalty as required by Rule 44.
- 11.3 As provided in Rule 67, the Protest Committee may, without a hearing, penalize a boat that has broken Rule 42.

12. PROTESTS

- 12.1 A boat protesting another boat, while sailing, shall hail the other boat, as required by Rule 61.1(a) as modified by Rule E6.3.
- 12.2 Boats filing a protest with the protest committee shall do so within 5 minutes of when the last boat finishes the Heat in which the incident occurred and shall also inform the race committee (PRO) within 5 minutes of the finish of the relevant Heat as required by Rule 61.3 as modified by E6.5. The protest is to be written. Skippers will be granted additional time to file a protest, if required in order to record relevant facts at the PRO's sole discretion.
- 12.3 Protests will be heard immediately following the heat in which the incident occurred and before the next heat.
- 12.4 As provided by RRS Rule 70.4 in a regatta being sailed under HMS, there shall be no appeals on decisions made by the protest committee. If redress is required, it

will that day consist of the average of the previous 4 races, or the races completed whichever is less.

13. SCORING

- 13.1 The Low Point System described in RRS Appendix A shall be used.
- 13.2 Fifteen races will be required to be completed to constitute the regatta.

14. EQUIPMENT CHECKS

- 14.1 A boat and her equipment may be inspected at any time for compliance with Class Rules and sailing instructions.
- 14.2 If any equipment is found to have been modified, skipper involved will be scored DNS for all races to the point when the modifications were discovered in the regatta.
- 15 AWARDS: Awards will be earned for the top 5 skippers for the 3 days sailing placements.
- 16 DISCLAIMER OF LIABILITY: Competitors participate in the regatta entirely at their own risk. See RRS Rule 4. The organizing authority will not accept any liability for material damage or personal injury sustained in conjunction with or prior to, during or after the regatta.
- 17. SPORTSMANSHIP AND CORINTHIAN SPIRIT; Remember we are always in Friendly competition.
- 17.1 In the event of any protested behavior which is deemed to be breach of good manners or sportsmanship, or which may bring the sport into disrepute, the PRO, any designated race official, or competitor may protest the party or parties in accordance with RRS #2.
 - 17.2 Penalties available to the PRO and/or protest committee include exclusion from the race in question or expulsion from the regatta as per RRS #69.2 and #69.3.
 - 17.3 In the event a skipper is penalized under RRS #2 at an AMYA event, a report of the incident shall be sent to the AMYA Class Secretary of the class being sailed and the AMYA executive board for review.
